- Chassis number(s) can be added to Annex 1 of this LONO after approval from Sales Engineering DAF Trucks Eindhoven N.V.
- Adequate clearance is required between any moving and fixed parts to allow for dynamic deflection.
- The required modification / installation will have to be undertaken by qualified and competent workshops and employees. Adequate instructions will be provided by Oliva Torras
- It is the sole responsibility of Oliva Torras to ensure that the vehicle that is subject to the anticipated modification/installation shall integrally meet the legal requirements of the country where the vehicle is to be operated and/or registered. Any responsibility to that extent for DAF Trucks N.V. is explicitly excluded.
